Subject: Receipt of 3rd and Final Status Report Pertaining to the Implementation of the

OIG's Driver Education Program Recommendations; Ref. IG-17-0001-SI

As you may recall, on September 2, 2021, the Office of the Inspector General (OIG) issued a final report on the Miami-Dade County Public Schools (M-DCPS) Driver Education Program. In that report, the OIG found that M-DCPS knowingly submitted over \$6.2 million of ineligible expenses for reimbursement from the Miami-Dade County *Drivers Education Safety Trust Fund (Trust Fund)*. The OIG report contained eight recommendations, to which the M-DCPS Administration embraced its full commitment to their implementation.

Since issuing the final report, the OIG has requested, and received, three progress reports from the Superintendent's Office. The first two status reports were received in December 2021 and in April 2022 and are posted on the OIG's website.²

On May 24, 2022, the OIG requested a third and final progress report to be provided on or before November 15, 2022. The OIG requested updates in four specific areas:

- Enrollment numbers for the summer Driver Education Program
- Teachers having the specific endorsement courses to teach Driver Education
- Status of Adaptive Driver Education vehicles and student eligibility to partake in Adaptive Driver Education Program
- Status of all driving range improvements and vehicle storage cages by school site

The Superintendent's Office submitted its last progress report on November 15, 2022. (Attachment 1). We have reviewed the status report and are pleased that M-DCPS has made

progress on the recommendations, especially in holding the Driver Education summer course at three locations servicing 99 students. The OIG conducted unannounced site visits at each school location during the summer months and were impressed with the enthusiasm exhibited by both students and teachers participating in the Driver Education Program. encouraging to see the implementation of endorsement courses to certify an additional group of twenty (20) teachers to teach Driver Education and augment the current group of eleven (11) fully endorsed Driver Education teachers.

Regarding the \$6.2 million financial liability owed to the *Trust Fund*, the OIG is aware that M-DCPS officials continue to engage with the Miami-Dade County's Office of Management and Budget (OMB). However, to our knowledge, there has been no acceptable corrective action plan or agreement on how to resolve the liability. Accounting for the ineligible reimbursements is a threshold matter for M-DCPS to receive future disbursements from the Trust Fund. The OIG, in our final report, acknowledged that this would not be an easy task and that full reconciliation could take several years. We also provided suggestions on restructuring Trust Fund payments prospectively to include advances subject to annual reconciliation. The OIG will continue monitoring this ongoing dialogue between M-DCPS and OMB, and the adoption of any new procedures to draw down future reimbursements and/or advancements from the Trust Fund.

The OIG is fully committed to ensuring that the M-DCPS Driver Education Program provides meaningful behind-the-wheel instruction to the students of Miami-Dade County and that disbursements from the County's Drivers Education Safety Trust Fund adhere to all applicable statutory requirements. While the OIG intends to fully monitor this program going forward, especially the resolution of the \$6.2 million liability, the OIG is closing this investigation and will not be requiring another written report from the Administration.

Dear Mr. Jimenez:

On May 24, 2022, the Miami-Dade Office of the Inspector General (OIG) requested a third and final update on Miami-Dade County Publics' (M-DCPS) as it relates to summer and fall programming on or before November 15, 2022, to provide information regarding the following:

 Enrollment numbers for the summer driver education program (June 14- July 21, 2022) by each of the three school locations with a breakdown of how many of those students were from non-public schools (Private Schools), Charter Schools, and M-DCPS students whose schools do not offer behindthe-wheel driving experience.

Update

A Driver Education course with behind-the wheel experience was offered at the school sites below during the summer of 2022. Marketing and registration for this program started on May 2, 2022. Emails providing information about the availability of the summer driver education program were sent to both charter and private schools in the county (Attachment 1). Information regarding the program was presented at the School Board meeting of April 13, 2022 and heavily promoted via

social media in English, Spanish, and Haitian Creole. As you know, School Board meetings are televised and streamed via several platforms. Further, a section of the summer programming website (summer305.dadeschools.net) was dedicated to the promotion of this program.

There were 65 M-DCPS students of the 78 whose schools do not offer behind-thewheel training.

Update

M-DCPS currently has 11 fully endorsed Driver Education teachers.

The driver education endorsement course consists of three modules:

- Module 1 Basic Driver Education and Traffic Safety (from June 14, 2022 to September 8, 2022)
- **Module 2** Advanced Basic Driver Education and Traffic Safety (from September 20, 2022 to December 15^{th,} 2022).
- Module 3 Administration and Supervision of Driver Education and Traffic Safety (from January 7, 2023 to May 20, 2023).

3. Status of retrofitting the two Adaptive Driver Education vehicles and the number of eligible students surveyed by the Department of Exceptional Student Education (ESE) to partake in Adaptive Driver Education for the fall semester.

Update

- a. The District has identified the vendor who can adapt two driver education vehicles and has created the purchase orders to retrofit the cars. These two retrofitted vehicles will be available by the beginning of the second semester (January 24, 2023).
- b. The Department of Exceptional Student Education (ESE) and the Department of Life Skills sent out Weekly Briefing #34020 (Attachment 2) on September 8, 2022, to all high school principals and assistant principals to complete a survey identifying any students who are interested in taking Adaptive Driver Education. Another weekly briefing to inform school-site staff about the availability of Adaptive Driver Education for the second semester will be sent on December 1, 2022.
- c. After weekly briefing #34020 on availability of the Adaptive Driver Education program was released, one student at Hialeah Miami-Lakes Senior High School was identified. The Department of Exceptional Student Education (ESE) and the Department of Life Skills have worked with the Driver Education Curriculum Support Specialist to provide adaptive driver education to this student at the school site this semester. The instructor added a spinner knob (a steering wheel adaptation) that has allowed the student access to behind-the-wheel instruction.
- d. Information regarding the Adaptive Driver Education program in our District has been provided through weekly briefings, presentations, a parent flyer (Attachment 3), to agencies and staff, including school-site administrators, school-site LEAs (Local Education Agency representative. This person is responsible for the ESE compliance activities at each school. There is one LEA representative at every school), school-site ESE program specialists, counselors, and region directors. The communication has included:

- e. The ESE department identified 115 students in grades 9-12 with orthopedic impairments as either a primary or secondary exceptionality. We have reached out to staffing specialists and other staff from these schools to ensure they are familiar with the availability of Adaptive Driver Education during the second semester of the 2022-2023 school year and the procedures for enrolling students in the program.

<u>Update</u>

- a. South Dade Senior High School currently has a driving range, security cages, cars, and is offering behind-the-wheel instruction to students during the 2022-2023 school year.
