Subject: Children's Trust Grant Recipient Pleads Guilty to Fraud, Ref. IG17-0036-I

Kelly Regalado, former Program Director of United Martial Arts Academy, Inc. (UMAA), a now-dissolved Florida corporation that was awarded grants from The Children's Trust,<sup>1</sup> pled guilty today to Organized Scheme to Defraud, a first-degree felony, and Wire Fraud. Regalado was adjudicated guilty and sentenced to 10 years probation. UMAA also pled guilty.

UMAA was originally established in 2004 by Regalado and her husband to operate a martial arts academy in the Homestead area. The academy was partially funded through The Children's Trust to operate both after school and summer programs, which included a tutoring component. The Children's Trust's grants partially reimbursed UMAA for certain expenses pursuant to a pre-set contract formula. Regalado oversaw UMAA's office administration and caused fraudulent information to be entered into The Children's Trust computerized financial program, upon which reimbursement was based. This information included false student attendance data, false employee pay data, and false expenses for goods and services purportedly purchased from third party vendors. When The Children's Trust became suspicious and demanded further proof of expenses, Regalado caused fraudulent UMAA bank statements to be sent to The Children's Trust. Suspecting fraud, The Children's Trust referred the case to the OIG for further investigation.

The OIG investigation, conducted jointly with the State Attorney's Office, determined that UMMA used a variety of schemes, including billing for ghost students, employees, and expenses, to illegally obtain Children's Trust funds. As part of today's plea agreement,

which has been sanctioned by The Children's Trust, Regalado and her husband sold their homesteaded property and repaid the Trust \$180,000 in restitution. She also paid costs of investigation. Further, Regalado is debarred from contracting with Miami-Dade County for a period of five years, the maximum time allowed under the Code of Miami-Dade County. Moreover, the Court entered orders permanently dissolving UMAA from ever doing business in the State of Florida.

The OIG appreciates the collaboration and assistance of The Children's Trust.
